Managers' Report: Mr. Kramer gave his report. He first led off by stating they have a meeting set up with Penn Dot, himself, Tony, and Dan this Thursday for the 13th Street Waterline project to discuss every option there is possible and will keep council and Rich updated on the outcome. He then mentioned the Borough just finished the Liquid Fuels audit for 2020 and 2021. He should get it finalized by the end of this week. Next, Mr. Kramer said the LSA grant for \$569,000 cite prep work for the Civic Center will be announced in January. He received an Email that day for Monaca Lofts. They are doing surveying and some sample work first week in January. He emailed them back to see a timeline since police and CommuniCylce currently utilize that building. He announced the Borough Christmas Party is Friday at Monaca Turners bowling alley between two and six o'clock in the evening. He had nothing further to report. There were no questions.

VP Shotter asked Brittany to make sure she adds in the minutes that under bills he abstains from check #8672. Pres. Booher asked if Ken has to as well. VP Shotter said no.

- 4. Mr. D. Wilson **motioned** to adopt Resolution No. 11-22, Police Pension Plan. Second by Mr. Mitchell. Motion carried unanimously.
- 5. Mr. LaPearle **motioned** to adopt Resolution No. 12-22 Real Estate tax, with no tax increase and automatically adopts Ordinance No 986. Second by Mrs. Majors. Motion carried unanimously.
- 6. VP Shotter **motioned** to adopt Resolution No. 13-22 Fire Tax, with no tax increase and automatically adopts Ordinance No 985. Second by Mr. D. Wilson. Motion carried unanimously.
- 7. Mr. Kramer explained the quote from W. B. Wells Co. INC for the WWTP. Mr. D. Wilson **motioned** to approve quote from W. B. Wells Co. INC. in the amount of \$14,548.40 for the WWTP. Second by Mr. McLaughlin. VP Shotter asked a question. Motion carried unanimously.
