

ADVERTISEMENT FOR BIDS

Sealed proposals for the Pennsylvania Avenue Streetscape - Phase I (from 9th to 15th Streets) project shall be received by the Borough of Monaca, 928 Pennsylvania Avenue, Monaca, PA 15061 until 1:00 PM prevailing time on the 22nd day of February, 2024 for furnishing labor, materials, and performing all work set forth in the advertisement, general conditions, drawings, and specifications. Bids shall be publicly awarded within sixty (60) days of the bid opening at the Borough of Monaca Regular Council Meeting.

Invitation, preparation, submittal, bidding requirements, all materials furnished and all work shall conform to applicable parts of the contract documents. The project includes the construction of new streetscape and public realm amenities as well as the associated roadway improvements, paving, and utility work.

Plans, specifications and bid documents are available for inspection at the Borough of Monaca offices at 928 Pennsylvania Ave, Monaca, PA 15061. A pre-bid meeting will be held on February 6th, 2024 at the Monaca Municipal Building at 10:00 AM. All questions and answers will be provided to bidders of record as addenda to the drawings and specifications and will become part of the contract. Questions must be submitted no later than 5:00 PM on February 9th, 2024. Questions placed by telephone or facsimile will not be honored.

Each proposal shall be accompanied by either a certified check or surety company bid bond in the amount of not less than ten (10%) of the contract amount. The same shall be made payable unto the Borough of Monaca.

The minimum wage rates for each craft or classification of all workmen needed to perform this contract during the anticipated term hereof shall be governed by State Prevailing Wage Rates.

Upon successful award of the contract, a 100% performance, 100% payment and 10% maintenance bond shall be required. No bids shall be withdrawn for a period of sixty (60) days after the time set for the opening of bids.

Bids, whether mailed or delivered in person, shall be sealed, marked "Pennsylvania Avenue Streetscape - Phase I" and addressed to Borough of Monaca, 928 Pennsylvania Avenue, Monaca, PA 15061.

The Borough reserves the right to reject any part of or all proposals, or to waive any irregularity in the proposal when the Borough deems such action advantageous to the Borough.
